**1. Grant of Copyright License.** Subject to the terms and conditions of this Agreement, You hereby grant to Jane Street and to recipients of software distributed by Jane Street a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable copyright license to reproduce, prepare derivative works of, publicly display, publicly perform, sublicense, and distribute Your Contributions and such derivative works under any licensing terms, including without limitation (a) open source licenses like the Apache License and OCaml Licenses; and (b) binary, proprietary, or commercial licenses.

**2. Grant of Patent License.** Subject to the terms and conditions of this Agreement, You hereby grant to Jane Street and to recipients of software distributed by Jane Street a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable patent license to make, have made, use, offer to sell, sell, import, and otherwise transfer the Contributions under any licensing terms, including without limitation (a) open source licenses like the Apache License

and OCaml Licenses; and (b) binary, proprietary, or commercial licenses. This license applies only to those patent claims licensable by You that are infringed by Your Contribution(s) alone or by combination of Your Contribution(s) with other inventions.

**3. Limitation of Licenses.** The licenses granted in this Agreement will continue for the duration of the applicable patent or intellectual property right under which such license is granted. The licenses granted in this Agreement will include the right to grant and authorize sublicenses.

**4. You Are Able To Grant Us These Rights.** You represent that You are legally entitled to grant the above license. You represent further that each employee of the Corporation designated on Schedule A below (or in a subsequent written modification to that Schedule) is authorized to submit Contributions on behalf of the Corporation.

**5. The Contributions Are Your Original Work.** You represent that each of Your Contributions is Your original creation. Should You wish to submit work that is not Your original creation, You represent that you will submit it to Jane Street separately from any Contribution, identifying the complete details of its source and of any license or other restriction (including, but not limited to, related patents, trademarks, and license agreements) of which you are personally aware, and conspicuously marking the work as "Not a Contribution. Notification of Changes.** You agree to notify Jane Street of any facts or circumstances of which you become aware that would make these representations or provided information inaccurate in any respect, including when any change is required to the list of designated employees authorized to submit Contributions on behalf of the Corporation, or to the Corporation's Point of Contact with Jane Street.
